- 2. The Corporate members who had participated in the remote e-voting and had provided the scanned copy of the resolution passed at their Board and Power of Attorney for authorization to exercise their votes through e-voting have been taken into account.

Our responsibility as a scrutinizer for the voting process is restricted to make a consolidated scrutinizer's report for the votes cast "in favour" or "against" the resolutions stated above based on the reports generated from the e-voting system provided by CDSL and Polling Papers in the 33rd Annual General Meeting in a fair and transparent manner.

We submit our report as under:

- 1. The E-Voting period remained open from 22nd September, 2019 at 9:00 A.M. and ended on 24th September, 2019 at 05:00 P.M.
- 2. The shareholders holding shares either in physical form or in dematerialised form as on the "cut off" date, i.e. 18th September 2019 were entitled to vote electronically on the proposed 5 (Five) resolutions as mentioned in the Notice of the 33rd Annual General Meeting of" Swetha Engineering Limited" (Item Number 1 to 5 of the Notice of the 33rd AGM of Swetha Engineering Limited)
- 3. Polling through Ballot / Polling Papers was conducted in the 32nd Annual General Meeting and the same was recorded by me. After the time fixed for closing of the poll by the Chairman, One (01) ballot box kept for polling were locked in my/our presence with due identification marks placed by me/us.
- 4. The locked ballot boxes were opened in the presence of 2 witnesses and poll papers were diligently scrutinized and signed.
